## RESIDENTIAL CONSTRUCTION COORDINATOR

**Location:** Utica NY

The position may be required to travel occasionally to attend paid trainings to obtain and maintain certifications.

**Job Description:** The HomeOwnershipCenter is looking for someone who is motivated and enthusiastic about helping to revitalize the communities we serve. The Residential Construction Coordinator provides assistance to property owners in determining housing rehabilitation needs, estimating costs, preparing bid documents, selecting contractors, and monitoring rehabilitation projects.

#### Work To Be Performed:

- 1. Inspects property and advises owners on housing rehabilitation needs.
- 2. Prepares work write-ups and cost estimates for single family and multi-family projects. Writes detailed construction specifications.
- 3. Prepares construction contracts for property owners and obtains bids from contractors.
- 4. Inspects rehabilitation work and authorizes payments. Approves change orders and obtains lien waivers prior to final payment.

#### Skills to be successful in this role:

- Working knowledge of building construction and rehabilitation techniques and general contracting and construction project management.
- Working knowledge of and experience in applying building, zoning, electrical, sanitation, health, and fire codes.
- Basic mathematical skills including the ability to add, subtract, multiply, divide and compute percentages with accuracy.
- Strong people skills
- Ability to work on projects independently with strong personal organization, decision-making and problem-solving.
- Friendly approach in person and on telephone. Ability to communicate with diverse client base.
